Call to Order

Council President Lloyd Corder called the meeting to order at 7:00 p.m.

Public Participation

Shane Scigliano of 206 Ridge Avenue stated that on Thursday evening he started to notice smoke from a wood burner that is being used by Paff Construction. He stated that the smoke covered the hollow on Brighton Road, came up the hill and filled several homes on Ridge Avenue, adding that he woke up coughing and thought his house was on fire. Mr. Scigliano stated that more than anything else this situation is a health concern.

Tom Paff, owner of Paff Contractors located at 6800 Brighton Road stated that the equipment in question is a new wood burner that provides heat for his buildings. He stated that the burner was initially installed incorrectly. Mr. Paff stated that the burner works off a power converter that pushes air through it, adding that the fire is smothered if there is not enough air. Mr. Paff stated that they ended up choking the unit, which caused all of the smoke. He stated that the unit is now working properly and that he has video tape of the unit working at full capacity showing that there is barely any smoke. Mr. Paff apologized for the initial problems caused by the burner. He stated that the unit has been inspected by the Allegheny County Health Department and by the borough's code enforcement officer, adding that everything is up to code. Mr. Paff stated that his company is environmentally conscious and LEED certified. He stated that nothing is being burned in the unit that could emit toxins into the air.

Michael Wrbas of 7138 Belle Riviere Court stated that he has been a resident of the borough for 22 years and is interested in filling the vacant council seat. He stated that he has 41 years of banking experience and is currently an Assistant Vice-President at First Niagara Bank in Bellevue. Mr. Wrbas stated that he is also a retired officer with the United States Air Force Reserve, adding that he retired with the Rank of Major.
